

Privacy Policy

Information Collection and Use

Any forms of contact information that you provide to us will be considered permission to use that method of communication (only provide a phone number you want us to call or email you want us to email).

Apply Online

In order to process your loan application, we require basic information about you and a means to contact you. The information we require is your name and the address in which you want a property tax loan for. The contact information you provide can be either your phone number or email address. We require this information so we can verify your eligibility for a property tax loan and also so we can contact you with the results.

Application

Some of the information you provide when you 'Apply Online' will be used in your application. During the application process we can correct this information if it's erroneous.

Cookies

We store certain configurations and preferences in a cookie. If you reject or disable the cookie, you can still browse our website, but you may have difficulty logging in or transitioning between our mobile site and regular site. We do not share any personally identifiable information provided by this cookie with any third party. We may, however, link data stored in cookies to the personally identifiable information you submitted while on our site. This allows us to personalize your online experience and discern user preferences.

Log Files

We use IP addresses to monitor site usage for marketing analytics, track site errors, and for security.
